Direct Care Wage Updates

- Happy News – Specialized Residential DCW will be added to the Per Diem in FY 2024!
 - Rate calculated from 6-month average based on FY23 data
 - Additional approved DCW rate increase for this year will also be added
 - Specialized Residential Providers will receive a communication from Provider Network on each of their locations individual rates
- Please remember to submit FY23 workbooks as soon as possible
 - We understand appeals can hold things up
 - We **must** close out all FY23 workbooks by end of calendar year



Internal Behavioral Services Team

- Outcomes we expect to see:
 - Increased customer choice of provider for behavioral services
 - More appropriately matched services
 - Quicker access to services
 - Decreased time monitored by BTC
 - Reduced recidivism
 - A gradual reduction in the number of customers...
 - residing in undue restrictive housing,
 - exposed to restrictive and intrusive interventions,
 - requiring psychiatric hospitalizations, and/or
 - losing placement due to behavioral concerns
